Consent, Release and Waiver

I affirmatively release, hold harmless and agree to indemnify the Buffalo Sabres, its advertisers, sponsors and affiliated entities and persons, and their respective agents and employees, from and against any and all claims, demands and liabilities of any kind arising out of any Exploitation or in connection the Contest (including, without limitation, any claim relating to distortion or manipulation, whether intentional or otherwise, of video, film, photograph or other audio-visual content submitted or taken in connection with the Contest).
